Production Facility Visibility Within The I-REC(E) Registry



Introducing Facility Finder

Following stakeholder feedback and a formal public consultation conducted by the I-TRACK Foundation, Xpansiv is introducing Facility Finder to the I-REC(E) Registry.

Facility Finder improves visibility of production facilities while preserving Registry neutrality and established market roles.

What Is Facility Finder?

Facility Finder is a contact facilitation tool allowing Registrants to *optionally* make their details visible to registered Participants seeking I-REC(E) procurement opportunities.

To preserve Registry neutrality and ensure alignment with the I-REC Code and governance framework, it does **not** introduce:

- Trading capability
- Price discovery mechanisms
- Matching or RFQ tools
- Transactional functionality within the Registry

All commercial engagement remains bilateral and outside the Registry.

How It Works

Registrant Opt-in

- Registrants can elect to opt in to Facility Finder within the Registry, making all production facilities associated with the Registrant account visible through Facility Finder.
- By opting in, Registrants consent to being contacted by Participants and Platform Operators via a designated enquiry email.
- Registrants may opt out back out at any time.

Participants and Platform Operators Search

- Facility Finder allows all registered Participants and Platform Operators to find opted-in production facilities.
- Participants and Platform Operators can search visible facilities using defined filters (e.g., country, fuel type, commissioning date) and then initiate contact directly with the Registrant outside of the Registry.

No issuance volumes, certificate availability, pricing, vintage, or transactional data are displayed.

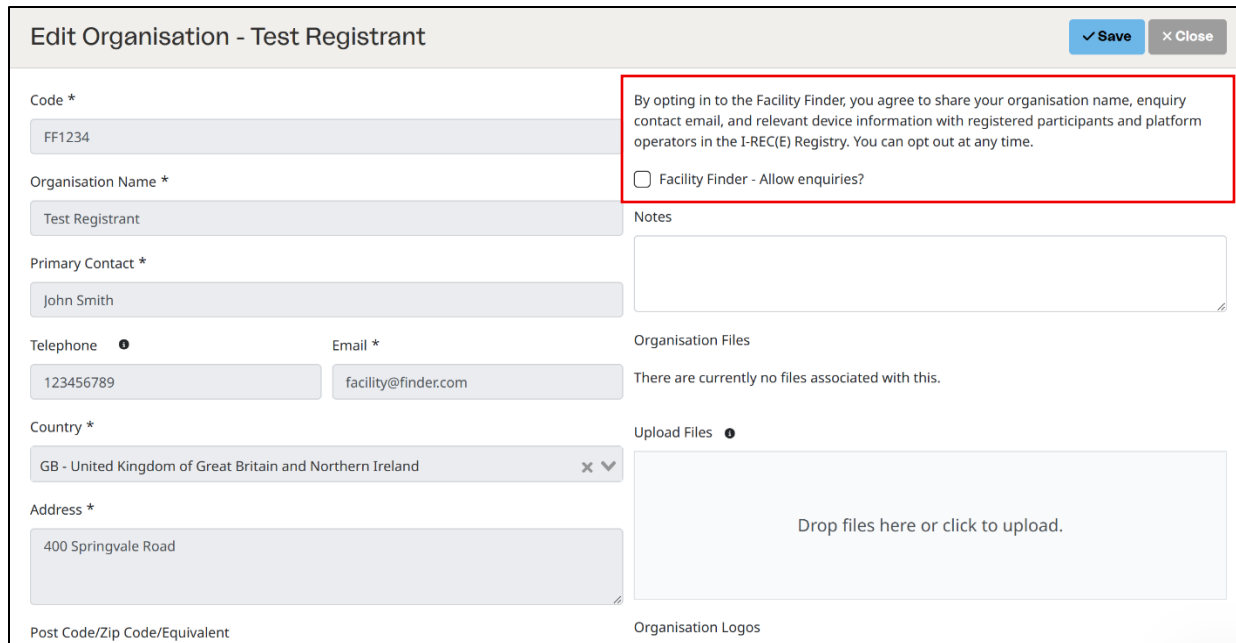
Registrant Opt-In

Opting In

Step One: Log in to your account in the I-REC (E) Registry using your email address and password.

Step Two: Navigate to the Organisation Admin page.

Step Three: Click Edit on the Organisation, a new field (shown in the red box) is present to allow opting in

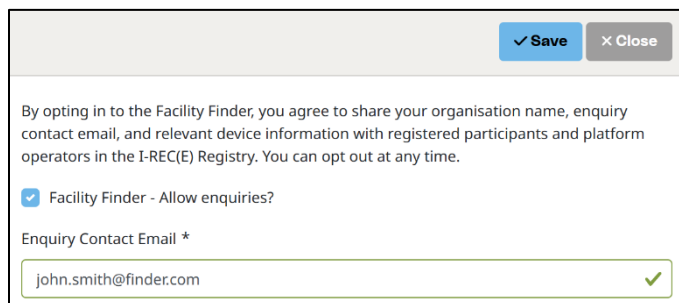

Step Six: Click Save

Opting Out

The default position for Registrants is to be opted-out, but if you change your mind after having opted-in, opting out is the reverse of opting-in.

Step One: Log in to your account in the I-REC(E) Registry using your email and password

Step Two: Navigate to the Organisation Admin page

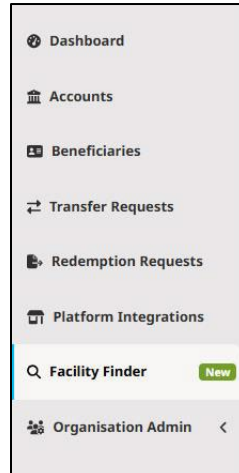
Step Three: Click Edit on the Organisation

Step Four: Untick the “Facility Finder- Allow Enquiries?” opt-in checkbox

Step Five: Click Save

Participants and Platform Operators Search Using Facility Finder

Step One: Navigate to the new Facility Finder option in the menu



Step Two: To use the Facility Finder, simply enter search criteria and click Search. Search criteria that can be used are:

Country (mandatory) - the country the facility is located within

Fuel Type (mandatory) – the type of fuel used to produce electricity by the facility

Capacity (optional) – a minimum and maximum capacity range

Commissioning Year (optional) - the year the facility was originally commissioned in.

Facility Finder is a search tool that enables you to identify production facilities that have opted in to be included in this directory. Facilities are added when Registrants choose to make their facilities available for discovery.
